

AC Current Transducer AT-B10

Split-core transducer for the electronic measurement of AC waveform currents, with galvanic separation between the primary circuit and the secondary circuit. 0-10 V DC switch voltage output proportional to the RMS value of the primary current.

Caution, Risk of electrical shock



The transducer shall not be put into operation if the jaw opening is open

(split core version) or the installation is not completed. Installation and maintenance shall be done with the main power supply disconnected except if there are no hazardous live parts in or in close proximity to the system and if the applicable national regulations are fully observed.

Dimensions AT-B10 (in mm)




